CBSE has issued advisories to schools for adopting of inclusive practices; examination byelaws of the Board have extended various exemptions for these students. Many schools have set the examples in the field of inclusive education in true sense and assisted the students with special needs. Depends upon the type of disabilities, severity levels and associated conditions inclusive practice of one school may differ from other school.
