The theme for this year's Shikshak Parv has been decided as '*Quality and Sustainable Schools: Learnings from the Schools.*

The inaugural conclave will be held on 7th September, 2021 at 11 AM wherein Hon'ble Prime Minister of India will address the stakeholders associated with education. It will be followed by webinars, discussions, presentations etc. up to 17th September, 2021 in which the educational practitioners from various schools of the country have been invited to share their experience, learnings and the roadmap ahead.
