Capacity Building Programmes for teachers teaching Early Childhood Care & Education in Class XII

NEP identifies that over 85 percent of a child's brain develops by the age of 6 years and thus emphasizes on providing critical importance to appropriate care and stimulation of the brain in the child's early years for healthy brain development and growth. It states that it is, therefore of the utmost importance that every child has access to quality Early Childhood Care and Education (ECCE).

CBSE had introduced 'Early Childhood Care & Education (Subject Code 842)' as a Skill Subject at Senior Secondary School level from session 2019-20 onwards. This course is aligned to level 4 of the National Skills Qualification Framework (NSQF)

In order to mentor/ handhold the teacher teaching ECCE in class XII, CBSE is organizing a Capacity Building Programme as per following details;
