Dear Principal,

The curriculum of German Language in Curriculum Document 2013 and 2014 prescribed the book *Team Deutsch 3* which was a complete uni-volume book for classes XI and XII. However the book has been bifurcated by the publisher recently in two volumes one for the class XI and the other for class XII. The allocation of chapters in these books for classes XI and XII has already been communicated to the teachers in the training programme conducted.

Due to this bifurcation, the correct allocation of chapters for classes XI and XII in the curriculum documents 2013 and 2014 shall stand revised as follows:

(ii) Team Deutsch 3/2 (Textbook and Workbook -Chapters 31- 36)

The revised curriculum of German for classes XI and XII w.e.f. 2012, Sample Question Paper for class XII and Marking Scheme are enclosed for the convenience of students and teachers.
