Dear Principal,

As its mandate the CBSE has been sensitive to the needs of all its stakeholders. A number of issues emerge once any reform is affected in the policy of assessment. The issues related to academic reforms are required to be addressed. One very pertinent issue which has been raised relates to the assessment in oral skills of the students who have "speech impediment" or who are "hard of hearing" or who have both disabilities partially or wholly, such students will find it difficult to be assessed in the skills of speaking and listening in English language. This assessment has been made compulsory in the formative and summative assessments w.e.f. 2012 in Secondary and Senior secondary classes, as per the 2014 and 2015 Curriculum guidelines uploaded on the CBSE Academic website <u>www.cbseacademic.in</u>.

In respect of students who have the above mentioned needs, the Board has tried to resolve the issue with the following alternatives as options:
