## Subject: Display board in Hindi and English languages for Tobacco Free Educational Institutions

Dear Principal,

Tobacco is the foremost cause of preventable death and disease in the world today and India is the second largest consumer of tobacco products. Nicotine is a highly addictive drug; and adolescents, who are still going through critical periods of growth and development, are particularly vulnerable to its effects. Smoking and other tobacco use causes numerous immediate, sometimes irreversible, health effects and risks that can seriously damage kids' health well before they leave school or reach adulthood. Because of the addictive power of nicotine, about three out of four teen smokers end up smoking into adulthood, even if they intend to quit after a few years. Smoking may also be a "gateway" to illegal drug use. Studies show that nicotine addiction often precedes the use of other drugs and is a risk factor for future use of drugs and alcohol.

CBSE strongly feels that students should abstain themselves from this deadly habit and has issued **circular no. 58** *'Guidelines on Protection from Exposure to Tobacco Smoke'* dated **November 20, 2009** which conveys WHO guidelines to all the schools affiliated to it on protection from exposure to tobacco/smoke. The Board had issued a detailed advisory in order to address tobacco consumption amongst adolescent population (Circular No. **Acad-04/2015 dated 24.04.2012).** The Board had also issued a latest circular **Acad.-14/2014 dated May 30, 2014** for sensitizing students for tackling Tobacco Epidemic and an **Anti-Tobacco pledge** as notification on World No Tobacco Day 2014.

In continuation to these samples of **display boards** in Hindi and English languages for **Tobacco Free Educational Institutions** is being shared. (Annexure-1) These have been issued by **Directorate of Health Services** – Delhi and display of both the boards is essential as per guidelines issued under Indian Tobacco Control Act COTPA 2003 for all schools. *Non-compliance will attract fine/challan as per Tobacco Control Laws of Government of National Territory Delhi.* 

Schools are in a uniquely powerful position to play a major role in reducing the serious problem of smoking and other tobacco use by kids. The above display boards may be put up at the **entrance gate outside the boundary wall, at the Reception, Cafeteria and other prominent places** in the size recommended without fail at the earliest.

Kindly refer to **Circular No. Acad.- 14/2014 Dated May 30, 2014**. An advisory was given in the third paragraph mentioning that it has come to the notice of the Board that some tobacco promoting firms are finding some innovative ways to be involved with the school children. It was, therefore, advised that no school affiliated to CBSE is permitted to allow its students to participate in the events sponsored by any firm or a subsidiary of a firm which promotes the use of tobacco in any form. It was also recommended that schools should not allow

any institution using brand name, emblem, trademark, logo or trade insignia or any other distinct feature directly/indirectly connected with tobacco products to be associated with students. It is to be further noted that these recommendations would apply only to activities and events that promote tobacco products and not otherwise.

This may be done at the earliest.
