I would like to draw your attention towards "Anti-corruption Poster and Video Competition" being held by Russia among BRICS countries. This Department along with Central Vigilance Commission is piloting the contest in India with the theme "Together Against Corruption!" from 1/6/2019 to 30/9/2019.

2. Competition's rules are available at the link <u>http://anticorruption.life/en</u>. It will be held for two categories- "The Best Poster" and "The Best Video". The contest will be open to all nationals of BRICS countries (individuals, creative teams and legal entities included) between the age of 14 to 35 years.

3. The contest will be held in two stages: Semi Final and Final. At Semi Final stage, each of the BRICS member countries will submit online; one best poster and one best video to Russia by 31/10/2019 for onward transmission to the International jury for selection of final winners. Besides, 10 best posters and 10 best videos will also be submitted by every BRICS country to be hosted on the official website for exhibition. Each contestant will have to register on the website. Prizes will also be distributed for the purpose. A National Committee; to be constituted for the purpose; will evaluate the works.
