Dear Principal

The *World Environment Day* is going to be celebrated by planting saplings / seedlings in the school / road leading to school / home/ appropriate public place from 05.06.2025 to 30.09.2025 in the country.

Building on the success of last year's campaign, this year's drive will be implemented through **Eco Clubs in schools** across India coinciding with the plantation season. All the schools are requested to lead the way by promoting sustainable living and environmental conservation through active participation in the drive. Post plantation all the saplings planted should be taken care of and nurtured by students under the supervision/guidance of teacher in-charge of Eco Clubs for MissionLiFE. The schools are suggested to-

- Encourage the student to plant the sapling with their mothers. This will strengthen the bond between student and their mother and Mother Earth.
- Put a placard displaying the name of the student and their mother along with the name of the saplings planted.
- A QR code may be generated for every separate species of tree planted to generate digital expertise for dissemination of botanical knowledge.
- Ask students to take selfies of the tree plantation activity.
