Subject: Participation in SHVR (Swachh Evam Harit Vidyalaya Rating) 2025 - reg.

Dear Principal.

This is to inform that Swachh Evam Harit Vidyalaya Rating (SHVR) 2025-26 has been launched by Hon'ble Minister of Education, Govt. of India. The SHVR 2025 is a revitalized, expanded and universal version of the earlier Swachh Vidyalaya Puraskar (SVP). All schools will now be rated and recognized based on a comprehensive 60-indicator based survey. The structural parameters of SHVR are aligned with the National Education Policy (NEP) 2020 and India's vision for a clean, green and inclusive school environment.

For implementing SHVR 2025, a SHVR portal and mobile application have been developed to facilitate digital participation, self-assessment, and monitoring. All schools will have to mandatorily participate in the Swachh Evam Harit Vidyalaya Rating (SHVR) 2025-26, before 30th September 2025, using either the mobile app or web-portal as per their convenience. The SHVR website https://shvr.education.gov.in also provides QR codes for downloading the Android and iOS mobile apps. For web-portal based participation, the schools can use the Login/ Signup option available at the homepage.

SHVR 2025-26 is designed as a mandatory programme for all schools having a UDISE code across the country, including Government, Government-aided, Private, Residential, Tribal, Minority, and centrally run schools (e.g., KVS, NVS) and CBSE-affiliated schools etc. It aims to empower schools to self-assess and improve across six key categories: Water, Toilets, Handwashing with Soap, Operation & Maintenance, Behaviour Change & Capacity Building and Mission LiFE activities.

In view of above, you are requested to do the needful and make a vital contribution towards shaping environmentally responsible citizens of this country.
