Subject: Observance of Vigilance Awareness Week (VAW) 2025 – reg.

The **Vigilance Awareness Week (VAW) 2025** will be observed across the country from **27th October to 2nd November, 2025** on the theme **“Vigilance - Our Shared Responsibility.”**

The observance of Vigilance Awareness Week aims to foster integrity, transparency, and accountability among all stakeholders and to promote a collective sense of responsibility towards building a corruption-free society. In this regard, all CBSE-affiliated schools are advised to observe **Vigilance Awareness Week 2025** in a suitable manner by organising a series of educational and awareness activities.

Suggested Activities

1. Display of **banners, posters, and hoardings** highlighting the theme *“Vigilance – Our Shared Responsibility.”*
2. Administration of the “Integrity Pledge” to students (Classes IX–XII), teachers, and all staff members. **(Text of the pledge is enclosed at Annexure -A.)**
3. Encouragement to all stakeholders to take the **e-Pledge** available on the Central Vigilance Commission’s portal at <https://pledge.mygov.in/cvc/>
4. Conduct of **awareness sessions** for senior students on ill effects of corruption on society and national development.
5. **Sensitisation of staff members** to promote probity, integrity, and moral values, with a special focus on youth engagement in fostering ethical practices.
6. Organisation of **lectures, panel discussions, debates, quizzes, essay writing, slogan writing, elocution, cartoon, or poster-making competitions** on themes related to integrity, ethics, and good governance.
7. Conduct of **seminars or workshops** aligned with the theme of Vigilance Awareness Week to encourage dialogue and reflection on the importance of vigilance as a shared social duty.
