Subject: Incidents of receiving fake circulars by schools affiliated to CBSE-reg.

It has come to the notice of Central Board of Secondary Education that some unscrupulous agencies are sending fake circulars/notifications to schools on various issues concerning CBSE. These communications use forged signatures of different senior officers of CBSE with an intent to deceive schools and harm the reputation of CBSE

Schools are, therefore, advised to verify the authenticity of all the circulars/notifications or any other information received in the name of CBSE from the official website(s) of CBSE. The main website of CBSE is www.cbse.nic.in and all other ancillary websites of CBSE should be approached through CBSE's main website.

It is also directed that all the schools affiliated to CBSE need to be constantly alert to such problems and if they receive any dubious mail/ communication, which remains unconfirmed from CBSE's website, the same must be immediately reported to authorities at either the concerned Regional Office or the Headquarters of CBSE at New Delhi with complete details.
