TRAINING PROGRAMME FOR TEACHERS TEACHING 'MULTI SKILL FOUNDATION COURSE' (SKILL SUBJECT) TO SECONDARY CLASSES

CBSE will be conducting a three-day training programme for the teachers teaching 'Multi Skill Foundation Course' (Skill subject with subject code 416) in classes 9th and 10th.

1. This online training will be conducted through the Google Meet platform.
2. All the schools (located in India or Overseas) who have applied for 'Multi Skill Foundation Course' (Skill subject with subject code 416) in their school w.e.f. session 2020-2021, but whose teachers have not undergone similar training earlier, can attend this training programme.
3. This training will be conducted in the blended learning format. The teachers will be given an orientation of Multi Skill Foundation Course and "Learning by doing" approach of teaching this skill subject to class 9th and 10th students. Training will be conducted using audio-visual tools, PowerPoint presentations and real examples from the classroom. There will be opportunity for teachers to practice at home and also get answers to their queries from the Master Trainers. Topics will be mix of vocational pedagogy and technical training with short assignment for teachers each day.
4. The live training sessions for the subject will be held on **27th & 28th October 2020 (9:30 am – 12:00 pm)** and on **30th October 2020 (9:30 am – 5:00 pm)** including breaks in between.
