## Awareness Webinar on Digital Citizenship and Digital Wellness and Digital Citizenship Educators Challenge

As today's world is undergoing a rapid technological transformation and youth is spending increasingly more time in the digital world, there is a greater need to make digital safety a priority. We need to empower our youth to become responsible & safe digital citizens and help them to use technology in a positive way. Teachers will play a large role in making this vision a reality. Teachers hold the key to enable students to remain safe online and teach them etiquettes required to thrive in a digitally driven world.

With this view, a 75-minute interactive awareness webinar is being organized for teachers on *'Digital Citizenship and Digital Wellness'* on 1<sup>st</sup> December 2021, during which teachers will be oriented on the need for integrating responsible Digital Citizenship in schools and ensuring Digital Well-Being of students.


