#### Online Fraud Awareness Programme in association with HDFC Bank

International Fraud Awareness Week is an annual programme hosted by the Association of Certified Fraud Examiners (ACFE) that took place between 15<sup>th</sup> and 21<sup>st</sup> November 2021, with the goal of raising awareness about financial fraud.

Every year, HDFC Bank participates in and commemorates this occasion. As part of this year's fraud awareness plan, the programme will be held across India through CBSE's Centres of Excellence (COE) and affiliated schools. The awareness / interactive sessions will last for 45-60 minutes and will include discussion, presentation, and interaction, during which the new mode of operation and preventative measures will be thoroughly covered. The fraud awareness training will be delivered in the form of a PowerPoint presentation. This will include information on the digital transformation of financial systems, case studies and videos and various types of cyber threats and modus operandi. These sessions will also help the participants learn about various financial frauds and security tips that will help them from getting defrauded.

Having knowledge on safe banking practices is very important in today's time, since there are many new avenues for conducting financial transactions and hence also to get defrauded. The objective of the awareness programme will be to help the participants understand good banking/ financial practices with engaging content.
