Schedule of the Teacher's Training programs on Design Thinking and Innovation (Skill subject) in face-to-face mode

With an aim to provide students with the tools and exposure to be able to address problems using the design thinking process, CBSE, in collaboration with the Ministry of Education's Innovation Cell and educators, including the faculty of IIT-Bombay, developed modules on 'Design Thinking & Innovation' for students of classes VI -XII.

These modules are designed in such a way that students learn to acquire both knowledge of design and practice of skills required to develop an attitude towards design. They are focused more on hands-on knowledge learnt by doing and acting upon challenges discovered within the community and surroundings.

In this regard, a one-day Teachers Training Program for Design Thinking and Innovation has been scheduled at multiple locations, as per the details mentioned below:


